2. Where it is discovered that an applicant has been punished on account of using unfair means in any examination or has been expelled from any educational institution, he / she shall not be admitted.
3. Cancellation of Admission: The University reserves its right to cancel the admission of successful Candidate under any of the following circumstances:
  - a) If the fee is not deposited by the stipulated date.
  - b) If the candidate does not join the particular programme by the stipulated date even though the Fee has been deposited.
  - c) If the candidate fails to furnish the proof of the stipulated minimum qualifications.
4. The Competent Authority of the University reserves the right to alter or modify the structure of any of the programs to attain the objective of excellence.
5. The University reserves its right to change the existing fee structure without any prior information.
6. Payment by a student of any dues shall not establish a claim to admission or re-admission.
7. For all purposes, decision of the admission Committee shall be final and binding on each applicant.
8. All fees once paid are not refundable for any reason whatsoever. Only Security Deposit will be refunded after necessary adjustments as required.
9. The University reserves its right to modify, alter and / or include any other terms and conditions that may be deemed necessary in the interest of the student.
